### VAT IN THE REAL ESTATE & CONSTRUCTION INDUSTRY

The seminar will discuss the national legal VAT framework for such transactions and offer guidance through examples as to how they should be treated for VAT purposes.

- VAT on the sale of non-developed building land;
- VAT on long term leases;
- VAT on rents;
- VAT under reverse charge for article 11B services;
- Transactions where property is exchanged for another property barter transactions (αντιπαροχή);
- VAT at 5% for primary residence;
- VAT at 5% for renovation of a primary residence;

The seminar is open to any professional with exposure to VAT matters in the real estate and construction industry such as business managers, accountants, CFOs and FCs, tax advisors, real estate agents et al.
